I understand that, currently under Washington State Athletic Association guidelines enforced by WWU, parents/fans will not be allowed to attend games or matches. See below for current guidance directly from WWU.

Q: Will Fall Classic be open to the public (spectators, family members)?

A: To best serve our Fall Classic athletes, meet state requirements and limitations for K-12 institutions, and to limit potential spread of infection, this year's Fall Classic will be closed to the public (i.e., spectators and family members). Our plans prioritize the experience and health of your athletes and their teams. WIAA limits how many spectators are allowed both at indoor and outdoor venues, and closing Fall Classic to the public allows athletes to support each other at their games.

Further, with current Covid distancing and testing requirements, parents will NOT be able to join the team for travel, meals, or any other activities (church, etc.).

If an emergency involving medical action or treatment is required, and neither the parent or the family physician can be immediately reached, by signing below, the parents hereby consent to the rendering of such emergency medical service(s) for the above-named student as shall be necessary in the medical opinion of the physician/medical professional rendering such service(s).
